

Juffali Training Center

In 1977, Juffali, in association with Daimler-Benz AG of Germany, set up an educational center to train young Saudis for technical assignment at various Juffali plants. The Center began modestly, with training comprising only two fields (Automotive Engineering and Maintenance Engineering) and only nine trainees.

Over the years, always with future market needs in mind, the Center began cooperating with other business partners as well, including Bosch, Siemens, the TVTC (Technical and Vocational Training Corporation) and the Saudi Institute of German Technology. Our reputation for excellence quickly grew, and we began training employees of many governmental and private sectors.

Today, Juffali Training Center is a thriving educational center and we have trained over 5,500 students – sometimes even over two generations of families. Working in conjunction with several Juffali partners, our Center offers technical courses in mechanical, electrical, welding and related trades, preparing young Saudis to contribute to the growth of the nation.

In line with the objectives of Vision 2030, we plan to further expand the Training Center and build a new, larger facility that will provide accommodation to encourage students to join us from all parts of the Kingdom. Our goal is to train 350 trainees annually in various sectors, meaning accommodating 700 trainees in various disciplines all under one roof.
